Welcome and Introductions

- Welcome and intros from the committee
- Apologies as shown above

Local Concern: Football Celebration, Glasgow Cross, 14 May.

- Football celebrations at Glasgow Cross
- Complain to us and MCC about the broken glass left in the aftermath of the celebrations
- There is a deposit return scheme in place, but this appears not to have been used
- Q to John Mason if he arrives what has happened to this scheme as the streets are littered with glass
- Urination around the cross during the event
- There are not enough toilets at the green and we raised a petition last year about this –
 1300 signatures to the council
- Councillors were supportive message to the councillors but we need support from them and the people who signed the petition that we do need more public toilets in the city
- ACTION missing councillors and MSPs to have this raised to them
- Q LS how could we mitigate better to prevent this happening no provision of toilets, no provision of skips for rubbish

Police Report

- PC Craig Burns Community Police Officer London Road
- PC Nicky McVeigh also part of the team
- CI Scott Simpson area commander for this area
- Pass local concerns/information/things on to them
- Lesley Docherty (Inspector) their immediate supervisor
- Even if information is not directly related to the area, they can pass it on to the relevant officers
- May 14 Van + 70 attending and drew other resources as required
- There was a public order response available as required
- Minor acts of disorder about 9pm when the crowd started to disperse
- 12 arrests for disorderly behaviour
- Focus on public safety
- By 11pm the area had been cleared

- Main issues in the area drug misuse and dealing, litter anti-social behaviour around it
 - o In the area there are Response colleagues, Uniform, Plain clothes
 - >30 arrest for dealing since the start of the year much the same on the other side of the High Street
 - Need information from members of the public either contact them direct or anonymously via Crimestoppers – have a form on line that can be completed
 - Finalising the Glasgow Green safety plan
 - Working with the Humane Society who know the area intimately
 - o All events for the summer have a safety plan in place
 - o It's a live plan feedback received is fed back into future event planning
 - Q re drug dealing at Bain Square behind the containers at St Lukes Police aware and are working to address the situation
 - o It is on the radar and they are dealing with it
 - Q CK-R needle stick injury to his dog, in his back, at the grassy knoll at Little Dovehill at the new flats
 - o Alarming number of needles behind the shops
 - o Police are working with the council to address this, but it keeps coming back
 - o Problem is the work cabins being used as shelter behind which to take drugs
 - Police are working with the council to clear and secure areas where anti-social behaviour is occurring
 - o Q TF (Chair) any input into safe consumption rooms? Not at constable level, no.
 - No discussions at present suggest take it up with local MP
 - CL council asking for input from residents about anti-social behaviour this may be straight from the council – they are dealing with the council anit-social behaviour unit on a daily basis – they gather evidence and pass it on to the council – this is effective to deal with problems – problems need to be reported to the police
 - Q TF (Chair) any other questions for the police?
 - Public toilets Greendyke St person in the underground toilet Actually on Greendyke Street opposite Glickmans – someone in the toilets that have been boarded up
 - Lots more rough sleepers at this time of year on the green if there is an issue they will speak to the council and get it secured
 - Q (member of public attending) motor scooters in the area being used some with more than one person on them
 - Treated as a motor vehicle under the terms of the RTA if they stop people using them and it's an adult they can give them a ticket for having no insurance
 - No license driving without a license, no insurance offence mostly children driving them
 - Q (Justin Dunne member of public attending) Gallowgate, Trongate, Saltmarket loud cars with exhaust noise – what is being done about it, speeding down High Street, London Road, Bell Street, etc
 - This is something they can look at
 - City Centre policing plan depends on many factors they will pass this on to the city centre team that makes the plan
 - Can issue them and the vehicle a warning and the vehicle can be seized if they reoffend within 6 months
 - Temporary orders to close street to break the circuit
 - There are temporary prohibitions on some streets around Blythswood Square
 - Outside 226 the pothole has been repaired so they rush along Gallowgate
 - Will invite us along to show how the speed traps work
- Police have said if we have concerns, we can email those to them

Councillor Reports

- Councillor Redmond did say he would be here but there has been a full council meeting, so he is not in attendance (no advance apologies)

- Email from Greg Hepburn to TF (Chair) disappointed he can't be here due to illness
- Was going to raise the levelling up bid to restore the Winter Gardens only bid from Central and they hope it will be successful
- Calton area partnership are hoping for a rep from the CC this will be Caitlin Longman
- Mentioned the council will be investing £1m extra on local infrastructure ideas sought from the CC
- Maeve Bradley (GCC) The cobblestones on Millroad Street may be repaired
 - The road don't have a pavement to get onto the road you need to cross the cobblestones and many of these are loose – many residents have mobility issues and cant get across -this is what this is abo0ut
 - o This is why this has been highlighted as an issue
 - Q is the plan to get the cobbles repaired the hope is to take them away because many are missing / loose – waiting on an inspection from roads to find out what is needed before a decision is made
 - Anything that people might wish to be included bollard replacement Claythorn Avenue – vans have knocked them over and vans are up on the pavement stopping access along the pavements – people on wheelchairs and with prams have to go onto the road to get around them. There are many reports of broken bollards in the area
 - o Not enough provision for parking locally which is contributing to the problem
 - LS At Glasgow Cross they have changed a lot of the flags and kerbs at the Barras but stopped before the cross so perhaps they can look at the cross too where the pavement are very poor
- If councillors are failing to turn up, can the CC ask them to submit a report to the committee in advance so it can be read out on their behalf
